Miller Medvesky In Pennsylvania there are three types of financial support that a spouse may be obliged to pay the other spouse as part of a divorce procedure or following a separation – slanderous support, pendant pension (APL), a Latin phrase that means "alimony during the litigation," and the subsequent pension, also refers, simply, as a pension. That meant that if someone paid \$1,000 a month in support of the spendents, APL or maintenance, the payer got a \$12,000 tax disbursement and would save federal taxes at \$12,000.
